Pet Grooming Agreement

Client Name:	Pet's Name(s):

This is an agreement between K9 Dorms, LLC and the pet owner whose signature (or electronic signature) appears below (hereinafter called "owner").

Current Vaccinations/Veterinarian Information: By signing this contract, owners verify their pets are current on Rabies. Owners are responsible for providing poof of Rabies upon Grooming appointment.

Satisfaction Guarantee: Our Groomer will go over what will be done and discuss options and additional services that may be needed. We pride ourselves in the quality of our styling; sometimes, corrections need to be made and we will welcome pet parents back for a quick fix within 2-days of their original appointment.

Aggressive Pets: If your pet(s) bite, has bitten, or is aggressive to people, other pets or specific grooming procedures you must notify the Groomer. Muzzles may be used if necessary. Muzzling will not harm your pet and protects both the pet and the Groomer. K9 Dorms, LLC reserves the right to refuse/stop services for such pet(s) at any time before or during the grooming process and charge a handling fee for aggressive dogs in addition to the regular grooming charge. If the pet should bite, the owner agrees to be responsible for any and all related medical bills, recovery costs, and loss of income and equipment damage.

Mat Removal: Pets with matted coats need extra attention during their grooming session. Mats left in a pet's coat only grow tighter, and can strangle the pet's skin, or eventually tear it open. Mats can be very difficult and painful for the pet to remove and may require the pet to be shaved. In some cases, pets may also exhibit brief behavioral changes. Prevention by scheduling regular grooming appointments or at home brushing is the best defense against matting. There is an extra charge for de-matting depending on the severity of the mat.

Accidents: There is always the possibility an accident could occur. Grooming equipment is sharp, even though we use extreme caution and care in all situations, possible problems could occur including cuts, nicks, scratches, quacking of nails, etc. In most cases this can happen when a pet is wiggling or moving around. If you arrive to pick up your pet and they are still being groomed, please do not talk to them or allow them to see you as this usually causes them to move. Every effort will be made to ensure your pet is groomed as safely as possible, but an excited pet can be dangerous to continue to work on. We reserve the right to end the grooming session, even if the groom is not completed, and the full grooming price will be charged.

Health or Medical Problems & Senior Pets: Grooming procedures can sometimes be stressful, especially for a senior pet or pet with health problems and can expose hidden medical problems or aggravate a current one during or after the groom. Because senior pets and pets with health problems have a greater chance of injury, these pets will be groomed for cleanliness and comfort, in styles that will not add to their stress. In the best interest of your pet this contract/agreement will give K9 Dorms, LLC permission to obtain immediate veterinary treatment for your pet should it be deemed necessary. We will do our best to contact you first, if contact cannot be made, we will take your pet to your authorized vet or to the nearest vet that is available. It is agreed that the pet's owner upon signing this contract/agreement will cover all expenses for veterinary care.



Pet Grooming Agreement - Continued

Parasites: We do not accept dogs with Fleas or Ticks for Grooming appointments. If Fleas or Ticks are found during the grooming process, your pet will receive a Flea Treatment Bath and an extra charge will be applied to your bill. We will contact you for immediate pick up to prevent spreading.

Late Pick-Ups: Please be on time to pick-up your pet(s). To enforce this policy, we may charge boarding fees for providing additional care for your pet.

No-shows and Cancellations: No-shows or cancellations less than 24 hours' notice are subject to a \$35 fee per pet, which will be added to your next appointment. We reserve the right to ask for pre-payment.

Returned Check Policy: Checks that are returned are subject to a \$35 Service Fee. Future appointments must be paid in full prior to the start of your pet's next appointment.

Hold Harmless Agreement: By signing this contract you agree to hold K9 Dorms, LLC it's owners, and employees harmless from any damage, loss, or claim arising from any condition of the undersigned pet(s), either known or unknown to K9 Dorms, LLC. It is also further understood and agreed the terms of this agreement can change at any time, without notice, and will overwrite any and all prior signed contracts or releases.
